**1. INTRODUCTION:**

This Memorandum of Understanding records the understandings reached between **Megahit Health Organization** (Hereinafter referred to as the “*Contractor*”/ “*Either Party*”) and

**2. PROJECT COVERAGE:**

**3. COMMENCEMENT:**

This MOU shall commence from the date of signing and shall remain in force for one year, unless terminated earlier by mutual consent or by the **Either party** for just cause.

Any variations/ modifications/ amendments to this MOU shall be mutually determined in writing by both parties.

**4. AGREEMENT OF MEGAHIT HEALTH ORGANIZATION:**

Megahit Health Organization agrees to undertake the following key responsibilities:

- To exempt the other party implement programs within it’s existing delivery and data systems;
- To recommend the other party access health relief items, medical

equipment and drugs from the government health facilities, national or joint medical stores applied for the set project;

- To invite and engage the other party on the available opportunities and/or health issues for the purpose of achieving health sustainable solutions;
- To temporally enroll the other party to participate in response to the set on going projects; and
- To provide capacity building and support the other party for the objectives of the Megahit Health Organization.

**5. PARTNERSHIP BETWEEN MEGAHIT HEALTH ORGANIZATION AND**

The intent of this Memorandum of Understanding is to form a strong relationship between **Megahit Health Organization** and

- Develop partnership and enter into agreements aimed for health sustainable developments and achieving objectives of the Megahit Health Organization;
- Foster health systems for health security that promotes good health and well-being;
- Ensure that individuals have access to the vaccines they need to survive and thrive;
- To combat maternal and child mortality high rates, HIV/AIDs, malaria, TB and other diseases;
- To promote and foster sustainable agriculture and food security that improve nutrition;
- To support the quality education and economic growth of children and families from socially disadvantaged backgrounds;
- To combat climate change with its impacts and ensure environmental sustainability;

- To ensure access to safe water, promote good sanitation;
- To offer a wide range of diagnostic tests and services to support accurate diagnosis and treatment;
- To offer comprehensive reproductive health services including family planning, pregnancy checkups and prenatal care;
- To provide post-abortion care services including counseling and medical support to ensure the well-being of individuals who have undergone abortions;
- To organize health runs and fitness programs to encourage physical activity and promote a healthy lifestyle;
- To develop and implement universal healthcare plans for persons with special healthcare needs, under privileged and socially deprived;
- Operate health centers, mobile outreach health camps to deliver healthcare services directly to those in need;
- Plan investments for a global initiative on digital health change and set health standards, precautions and guidelines;
- Develop a spirit of fundraise and/or leverage collective expertise and resources that maximize impact on public health;
- To create income-generating projects that supports the needy for economic growth and transformation of their homesteads;
- To establish family resource centers for rehabilitation, and provision of functional basic needs to people with disabilities, orphanage and vulnerable persons; and
- To monitor public health risks, mobilize rapid response teams and provide emergency health care, humanitarian aid, mental health and psychosocial support to affected populations for saving lives.

**6. REPORTING AND MONITORING:**

The **other party** shall provide regular reports to the **either party** detailing progress and challenges during the implementation of the project. This shall be captured through the report books provided. The **either party** shall support the other party in overcoming identified challenges whenever possible.

## **7. TERMINATIONS AND RENEWAL:**

The parties may mutually agree to terminate and/or extend this Memorandum of Understanding in writing, at any time.

In deciding whether to terminate or extend this contract, the parties shall take into account with:

- a) The availability of resources;
- b) The contract performance; and
- c) The contract compliance with the terms of agreement.

In the event of termination, the **Either party** shall give three days' written notice to the **Other party** prior to the date of termination.

Termination shall not affect any ongoing project commitments and obligations.

## **8. LIABILITIES AND INSURANCE:**

The contractee assumes no liability for any third party claims for damages arising out of the acts under this contract by the contractor.

## **9. PAYMENT TERMS:**

All payments shall be made directly on the service provider's bank account or to an authorized representative duly appointed by the service provider to receive cash on its behalf.
